BELTON AND MANTHORPE PARISH COUNCIL BURIAL GROUND

Belton and Manthorpe Parish Council burial ground is at the rear of the grounds surrounding St. Johns church in Manthorpe. It is administered separately from the Church Cemetery and is split by a concrete post and wire fence.

Local residents within the parish council boundaries may purchase graves (A Grant of Exclusive Right of Burial) on preferential terms, although other residents outside the parish boundaries may also acquire plots subject to availability and acceptance of differing terms.

To qualify as a parishioner of Belton and Manthorpe in regard to burial in the Parish Council burial ground, the person must satisfy these conditions:

- (i) He/She should have lived in Belton and Manthorpe parishes and within the parish boundaries for four years.
- (ii) Are listed on the Civil Belton and Manthorpe Electoral Register.
- (iii) Have lived in the parishes of Belton and Manthorpe as a child with their parents/grandparents for four years.
- (iv) Owned or leased a property in the parishses of Belton and Manthorpe for four years (should relate to no (ii))

The fees payments and sums set out below apply where the person to be interred or in respect of whom the right is granted is, or immediately before his/her death was a parishioner of the Council Parish of Belton and Manthorpe or, in the case of a still born child, where the parents are residents.

INTERMENTS

The fees indicated for the various heads of parts 1 & 2

(a) Do not include the digging of the grave

(b) Apply only where the interment is made between the hours of 10.00am and 4.00pm on a weekday or on the certificate of a coroner or the registered medical practitioner that immediate interment is necessary.

Part 1 for the interment in any grave

Of the body of a still born child, or a child whose age at the time of death did not exceed twelve months. NO CHARGE Of the body of a person whose age at the time of death exceeded one year £150.00

Part: 2. Exclusive Rights of Burial in earthen graves

In an earthen grave 8 feet by 4 feet £196.00

Of cremated remains in an earthen grave 2 feet by 2 feet £102.00

The fees indicated for the various heads of Part 2 include the Deed of Grant and all expenses thereof.

All fees apply per burial

To reserve a grave or cremated remains plot Exclusive Right of Burial fee to be paid at the time of reservation and Interment in Any Grave fee at time of interment to be paid on interment.

The fees payable for persons who do not qualify as a parishioner are as follows:

INTERMENTS

The fees indicated for the various heads of parts 1 & 2

(a) Do not include the digging of the grave

(b) Apply only where the interment is made between the hours of 10.00am and 4.00pm on a weekday or on the certificate of a coroner or the registered medical practitioner that immediate interment is necessary.

Part 1 for the interment in any grave

Of the body of a still born child, or a child whose age at the time of death did not exceed twelve months. NO CHARGE Of the body of a person whose age at the time of death exceeded one year £600.00

Part 2. Exclusive Rights of Burial in earthen graves In an earthen grave 8 feet by 4 feet £1080.00

Of cremated remains in an earthen grave 2 feet by 2 feet £1020.00

The fees indicated for the various heads of Part 2 include the Deed of Grant and all expenses thereof. All fees apply per burial

To reserve a grave or cremated remains plot Exclusive Right of Burial fee to be paid at the time of reservation and Interment in Any Grave fee at time of interment to be paid on interment.

INTERMENTS

The fees indicated for the various heads of parts 1 & 2

- A) do not include the digging of the grave
- B) apply only where the interment is being made between the hours of 10am and 4pm on a weekday or on the certificate of a coroner or the registered medical practitioner that immediate interment is necessary.

PART 1 FOR THE INTERMENT IN ANY GRAVE

- (i) Of the body of a still born child, or a child whose age at the time of death did not exceed twelve months £240.00
- (ii) Of the body of a person whose age at the time of death exceeded one year £600.00

PART 2 EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES

For the exclusive right of burial

1. In an earthen grave 8feet by 4 feet

£1080.00

2. Of cremated remains in an earthen grave 2 feet by 2 feet

£1020.00

The fees indicated for the various heads of Part 2 include the Deed of Grant and all the expenses thereof.

All fees apply per burial

To reserve a grave or cremated remains plot Exclusive right of burial fee (£1080.00 for earthen grave plot or £1020.00 for cremated remains plot) to be paid at the time of reservation and Interment in Any Grave fee at the time of interment to be paid on interment.

PART 3 MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on the grave in respect of which the Exclusive Right of Burial has been granted.

(i) A headstone of maximum dimensions shown below	£104.00
(ii) A small vase	£ 45.00
(iii) A memorial plaque over cremated remains	£ 45.00

(iv) A wooden cross £12.00

The fee shown in Part 3 (i) is for the first inscription only, for each additional inscription a fee of £33.00 is charged.

LIMITATIONS

- (i) Headstones: Maximum dimensions including the base plinth. 36 inches high x 26 inches wide. Headstones to be placed at the head of the grave and grave to be laid out similar to those in the churchyard.
- (ii) Vase: Maximum height of 12 inches. Under no circumstances can glass container be permitted.
- (iii) Plaques: 12inches square and set into the ground level with the surface.

In order to maintain an adequate standard of ground maintenance, the following limitations must be applied.

- (i) Not more than ONE vase. Which must be placed on the headstone plinth or in the immediate vicinity.
- (ii) Where no headstone has been erected, the vase must occupy the position normally taken up by the headstone
- (iii) In the area set aside for cremated remains, the vase is required to stand behind the memorial plaque.
- (iv) There can be no boundary markers, fences, stones or kerbs.
- (v) The surface of the grave must be level with the surrounding ground and after a period of time allowed for settlement, the area will be seeded and levelled. Therefore, rooted plants may not be planted.
- (vi) There can be no artificial flowers.

The fees and other charges, together with the limitations, were fixed by resolution of the Council.
