Meeting Minutes

1. Acceptance of Previous Minutes - 5th July 2016.

Action

1.1 The previous minutes were accepted unanimously.

2. Matters Arising.

2.1 Parking at the Old School.

Alec said the plans to improve the roadway into and through the Wood Yard by tarmacing the roadway and applying a spray tar and chipping surface finish should be completed this financial year. Work had been delayed pending a satisfactory quote within budget. The possible road spur to the left, inside the wood yard entrance would still be considered when the time came and dependant on funds.

2.2 Parking in Main Street.

Not now generally a problem. However there were occasions of dangerous parking on the apex of the bend outside the Old Forge. On one occasion someone had parked on the small triangle of grass against the wall, opposite the Forge It was then very difficult for drivers from the Church direction to see traffic exiting from Belton House entrance or anyone exiting that entrance to see traffic from the right. Anyone witnessing such parking should try to dissuade drivers from doing so.

Deployment of traffic cones by the National Trust, from before the Forge up to the Alms Houses, was still planned for popular visitor days but had not been out for August Bank Holiday as this had not been particularly busy.

2.3 Belton Crime Incidents - NHW.

Nothing to report since the last meeting.

2.4 NT Planting of Hedge along East side of Five Gates Lane.

Alec said that the new Outdoor Manager, Claire Barrett, responsible for Park and Gardens had still not had time to investigate this matter to consider any action. The matter was thus still on-going.
